



PERSONAL DATA PROTECTION CONSENT FORM

1 BACKGROUND

- 1.1 BW Group Limited and/or its affiliates and subsidiaries (collectively, “**BW Group**”) are subject to certain requirements with respect to the handling of personal data pursuant to “**Data Protection Laws**”, being all applicable data protection and privacy law in force from time to time or as re-enacted, applied, amended, superseded, repealed or consolidated, including without limitation, the European Union’s General Data Protection Regulation (EU) 2016/679, the UK GDPR (as defined in the Data Protection, Privacy and Electronic Communications (Amendments etc.) (EU Exit) Regulations 2019/419) and the UK Data Protection Act 2018.

4.2 Because BW Group operates internationally, it has computer systems based around the world, including in the United States. Therefore, if you provide BW Group with your Information, you understand that it may be received and processed by BW Group in the United States, where data protection and privacy regulations may not offer the same level of rights and protections as in other parts of the world, such as the EEA and UK. Notwithstanding, BW Group shall make reasonable efforts to apply the same degree of physical, electronic and procedural measures to protect your Information.

5 YOUR RIGHTS

5.1 Please note that it is voluntary to consent to BW Group's processing of your Information. The consent that you provide for the processing of your Information will remain valid until such time as it is withdrawn by you in writing.
