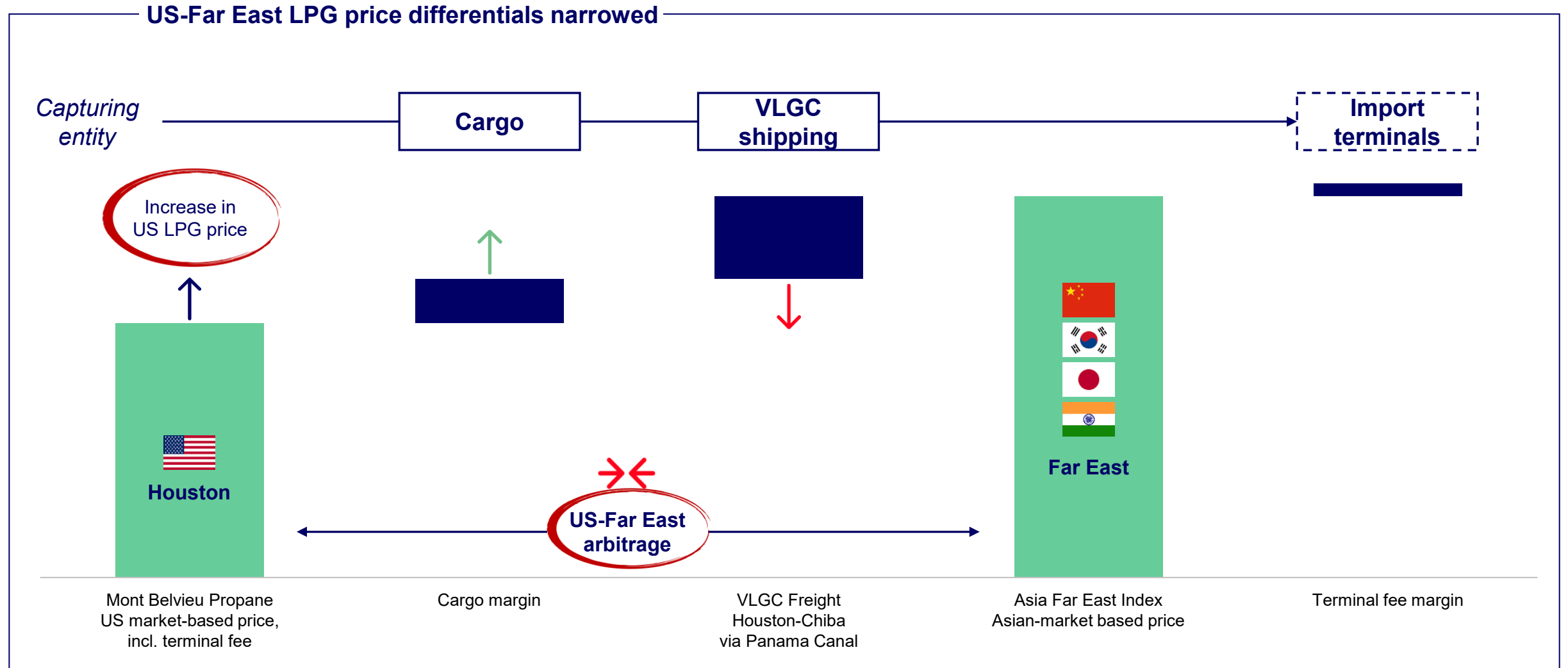

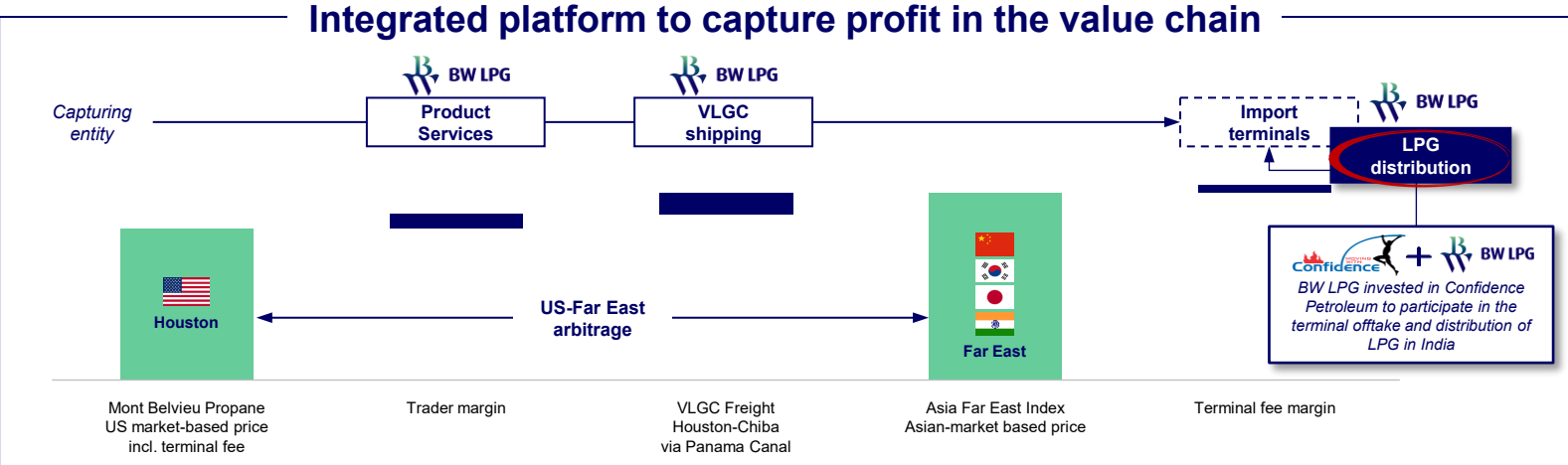

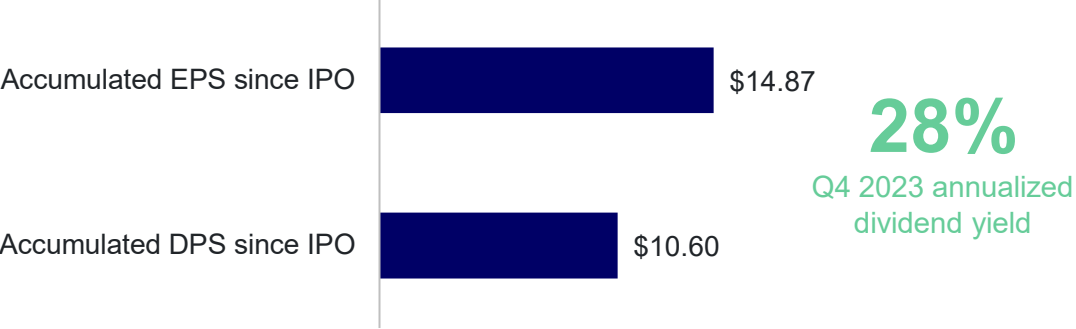

On track for US dual listing in Q2 2024

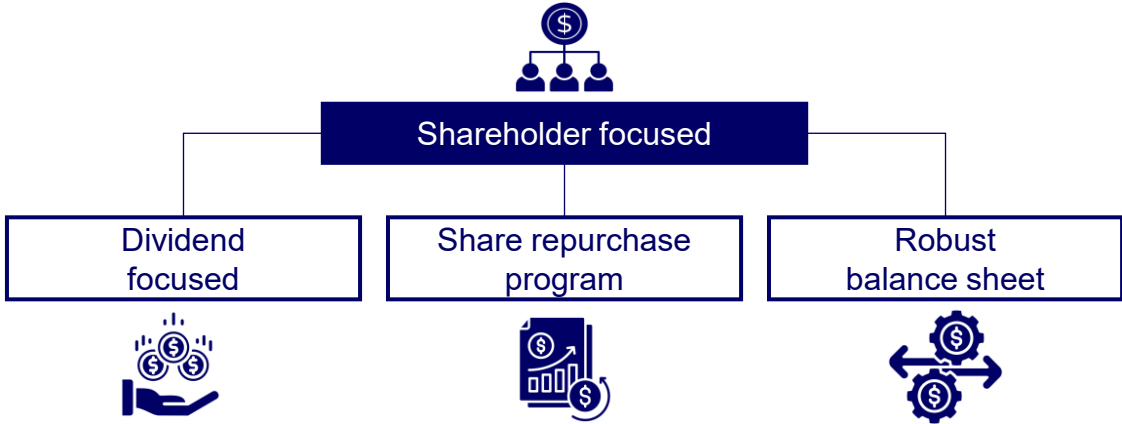


Since IPO, we have paid out 71% of our earnings as dividends

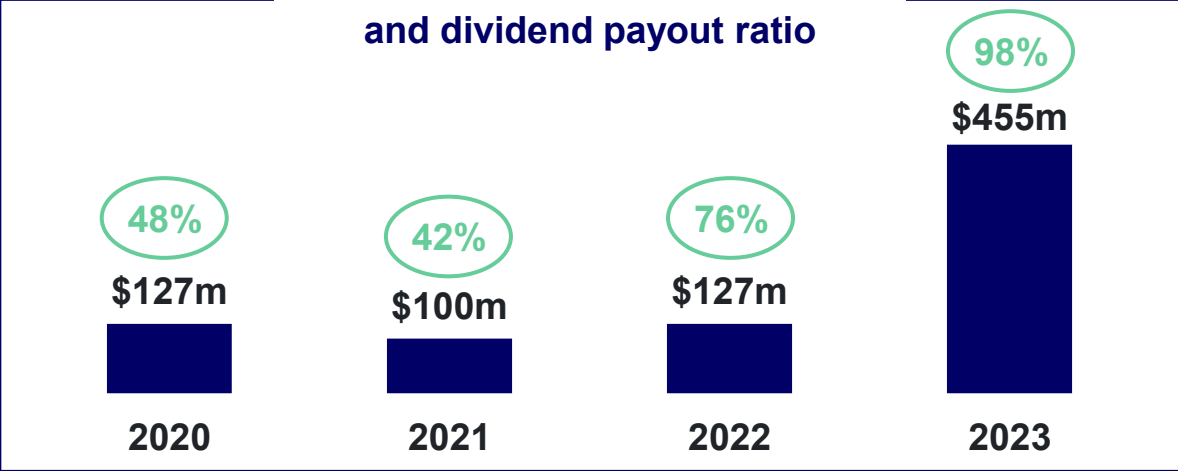
Historical accumulated dividend per share and earnings per share
